

Submission Information:

1. Nominees for the SAB should be recognized preeminent experts in science, technology, engineering, and/or technical program leadership.

2. Nominees must be U.S. citizens NOT currently employed by the Federal Government.

3. Nominees should have a current or recent security clearance at the SECRET or higher level.

4. The SAB is chartered under the Federal Advisory Committee Act; in accordance with DoDI 5105.04 and DAFI 90-1401 (DoD Federal Advisory Committee Management) SAB participants serve without compensation beyond reimbursement for allowable travel expenses.

5. Those selected for the SAB will be required to provide, among other information, a Financial Disclosure Report (OGE 450) before appointment to the SAB.

6. Appointments to the SAB are subject to SecAF and SecDef approval.

Submission Instructions:

1. Submit a separate nomination form for each nominee using the filename convention "Lastname_Firstname_Nomination.pdf".

2. Include the nominee's resume in PDF format using the filename convention "Lastname_Firstname_Resume.pdf".
